

£400 Cashback or Voucher of Choice – Element, Bermondsey

Terms & Conditions, July 2025

- 1. The incentive is open to all new students booking at Element Bermondsey, 78 89 Alscot Rd, London SE1 3AY, who book any room at Element Bermondsey for the 2025/2026 academic year.
- 2. The Incentive on offer is either a £400 cashback which will be paid via bank transfer to a UK bank account or a £400 voucher of the students choice.
- 3. The Incentive is open to the **next 20 bookings only.**
- 4. The Incentive is only available for new bookings for the 2025/2026 academic year only.
- 5. The Incentive is only available to bookings on a minimum of 51-week tenancy lengths.
- 6. The Incentive is subject to room availability and will be delivered on a first come first serve basis.
- 7. The Incentive is being offered by BREEVA II Student Accommodation S.A.R.L, c/o CRM Students Ltd, 78 Alscot Road, London, SE1 3AW
- 8. To be eligible for the Incentive:
 - a. the Student must have booked a room, paid their first rent instalment /or their rent in full and moved in to the property for the 2025/2026 academic year.
 - b. At the stage of booking, the student must enter the code **ELEMENT£400CB** in the box on the application form which requests details of any special requirements or preferences.
- 9. To claim the Incentive:

 - b. On receipt of the application from the Student, the Accommodation Manager will verify the student's eligibility to claim the Incentive.
 - c. Both the Student and the Guarantor (if applicable) must have signed the tenancy agreement.
 - d. The Student must have entered the bank details of the UK nominated bank account into the online Student Portal
 - e. The incentive will be provided either as a bank transfer of £400 into the nominated UK bank account or via email in the form of an e-Voucher.
 - f. The Incentive will be provided to the Student within two months after they have moved in for the 2025/2026 academic year
 - g. The Incentive must be claimed by <u>31st January 2026</u>, if unclaimed by this date the student will forfeit the incentive and no longer be entitled to receive it.
- 10. The Incentive will close at any given notice or when 20 eligible bookings have been made. Applications received after this will not be valid for the Incentive.
